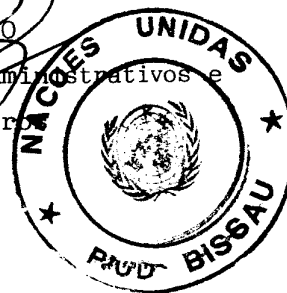

SERVICE AGREEMENT NATIONAL EXPERT

MEMORANDUM OF AGREEMENT made this 15 day of July 1994 between the United Nations Industrial Development Organization (UNIDO), and Mr. Gijsbert J. VAN MANEN (hereinafter referred to as the national expert)

WHEREAS UNIDO desires to engage the services of the national expert on the terms and conditions hereinafter set forth, and

WHEREAS the national expert is ready and willing to accept this engagement of service with UNIDO on the said terms and conditions,

NOW, THEREFORE, the parties hereto agree as follows:

1. TERMS OF REFERENCE

The national expert shall perform the services as outlined in the relevant job description. Subject to the agreement of both parties, this job description as well as the terms and conditions of service may be modified from time to time, as required in the interest of the project.

The national expert shall work under the direction of and shall report to the UNDP Bissau, GUINEA-BISSAU

2. DURATION OF AGREEMENT Seven months

This agreement shall commence on the 1 day of March 1994, and shall expire on the 30 day of September 1994, subject to the provisions of article 4 below. This agreement carries no expectation of renewal.

3. REMUNERATION see page 3, paragraph 14)

As full consideration for the services performed by the national expert under the terms of this agreement, UNIDO shall pay the national expert the sum of _____ per month. All payments shall be in local currency.

Costs incurred on project-related official travel shall be paid to the national expert by UNIDO on the basis of locally applicable standards up to the normal United Nations/agency standard subsistence allowance. Daily subsistence for the project-related official travel shall be paid to the national expert by UNIDO on the basis of rates established for locally recruited staff of the United Nations system.

The national expert shall have insurance coverage for medical expenses for himself or herself only, excluding dependants, at no cost to himself or herself for the duration of the present Service Agreement up to a maximum of \$US 10,000, or the equivalent thereof, per calendar year.

Equally, he or she shall be covered for the duration of the present Service Agreement in the event of death up to a maximum of \$US 25,000 or the equivalent thereof, and for permanent disability up to a maximum of \$US 40,000, or the equivalent thereof. Pension coverage is the responsibility of the national expert and is not provided for under this agreement.

4. RESCISSION

Either party may rescind this agreement at any time by giving the other party one month's notice in writing of its intention to do so. The one month's notice period applies to national experts holding an agreement of three months or more. For periods of less than three months, 15 days' notice applies.

12. SETTLEMENT OF DISPUTES

Any claim or dispute relating to the interpretation or the execution of this agreement that cannot be settled amicably shall be settled by binding arbitration. The arbitration panel shall be composed of a government official nominated by the national expert, a representative of UNIDO and a Chairman agreed to by both of them.

13. DESIGNATION OF BENEFICIARY

The national expert has designated _____, whose address is _____ as his/her beneficiary for all amounts standing to the national expert's credit under the terms of this agreement in the event of the national expert's death.

14. OTHER PROVISIONS

75% in US\$ = US\$ 2,499.75 per month
25% in Pesos = PG 10,165,650.— per month

Payments will be effected in monthly installments upon satisfactory performance.
